



the town complied with State and Federal requirements for procurement, conflict of interest/ethics, and contract documents. The town was not in compliance, but with guidance from the Vermont League of Cities and Towns (VLCT), DPS approved the town's revised policies and documents, which are available on the town website at https://townofwheelockvt.org/town-docs/

Wheelock's delinquent tax collector, Emily Purdy, attended the Sept. 2 Selectboard meeting and reported that delinquent tax balances have decreased to \$59,894 with a recent recovery of \$41,000. Town Clerk, Erin Swigert, will help Emily with the needed skills to enter the tax information directly into the town software system. This work will improve the timeliness and accuracy of reports that depend on this data.

Update on Town-wide Property Reappraisal

he appraisers working on Wheelock's town reappraisal project report they are moving into the steps of data entry, sales analysis, and development of new schedules. They are on schedule to complete the reappraisal for the 2026 Wheelock Grand List.

It is important to note that if a property owner is eligible for a property tax credit or 'income sensitivity payment', the credit is based on the prior year. New property assessments go into effect in the year following a reappraisal (in this case, 2026). A property owner will get the income sensitivity payment based on the previous year values, not the current year with the increased property value. The State of Vermont is not making any changes to address this payment lag.

Legislation requires all towns to complete a town-wide reappraisal every six years. This work can only be done by persons **certified** by the Vt. Tax Department (so the NEMRC group has been contracted). The State of Vermont is not increasing the annual state payment for reappraisals (\$5000 a year). Wheelock may need to raise additional monies each year for the reappraisal services reserve account.

Wheelock Seeks Planning Commission Members

↑ he Wheelock Selectboard seeks people willing to be appointed to a three-year term on the town's planning commission. A commission is usually made up of three to nine members and their primary duty is to prepare and amend the municipal plan.

Our current 2019 Town Plan will expire soon so it needs an update. It is posted at https://bit.ly/3VPaYL3

Sheffield recently completed an update to their town plan with a fivemember commission and the assistance of an NVDA specialist. They met once a month during the 2024 calendar year to complete their plan.

The Wheelock selectboard will be seeking a Municipal Planning Grant to hire a planning specialist to help us with this rewrite. The grant application is due soon, so setting up the planning commission is key.

Planning commissions may also take on other activities related to their role as leaders of the community on planning matters, including holding public hearings to determine future needs of the town, conducting surveys, holding discussion forums, and educating the public about current issues facing the town.

The town plan should bring a helpful long-term perspective to day-today decision-making. Ideally our commission will work to represent all community members and interests by including other public officials, businesses, interest groups, civic groups, and citizens in their work.
